**NACCS CONCLUDES SERVICE PROVIDER AGREEMENT WITH
'WiseTech Global Pty Ltd' REGARDING ADVANCE FILING RULES**

Kawasaki, Japan- 21 August 2013- Nippon Automated Cargo and Port Consolidated System, Inc. (NACCS Center) concluded service provider agreement with 'WiseTech Global Pty Ltd' (Sydney, Australia) to enable Carriers and NVOCCs in foreign countries, the filers of the newly enacted Japan's Advance Filing Rules, to report electronically through NACCS to Japan Customs.

While NACCS center has developed partnership with service providers based in major seaports where a substantial number of Japan bound containers are loaded, WiseTech Global Pty Ltd is the first service provider headquartered in Sydney, Australia, and it is expected to enhance the environment for the customers of WiseTech Global including potential filers in the region to be compliant to the Japan's Advance Filing Rules.
