NACCS HELD SIGNING CEREMONY FOR SERVICE PROVIDER AGREEMENT WITH 'CONEX' REGARDING ADVANCE FILING RULES

Kawasaki, Japan- 11 October 2013- Conex (France) and Nippon Automated Cargo and Port Consolidated System, Inc. (NACCS, Inc) concluded connection agreement on 23rd July, 2013, to enable AFR filing from overseas to Japan customs (Reference: NACCS Press release on 23rd July). On 10th October 2013, Mr.Gruson, CEO of Conex visited NACCS,Inc to attend signing ceremony.

Mr.Gruson commented that Conex fully supports AFR by using its robust business network especially in Europe and African countries, and both CEO confirmed closer cooperation between NACCS and Conex for the smooth implementation of AFR.

As of today, there are 18 authorized service providers of Japan AFR and the network of service providers covers all the major seaports of Japan bound maritime container shipping routes.

NACCS Center continues to cooperate with service providers to prepare itself fully for the launch of Japan Advance Filing rules in March 2014 by enabling Carriers and NVOCCs in foreign countries to report electronically through NACCS to Japan Customs.

NACCS CONCLUDES SERVICE PROVIDER AGREEMENT WITH 'Conex' REGARDING ADVANCE FILING RULES

Kawasaki, Japan- 23 July 2013- Nippon Automated Cargo and Port Consolidated System, Inc. (NACCS Center) concluded service provider agreement with 'Conex' (Orchies, France) on 18 July to enable Carriers and NVOCCs in foreign countries, the filers of the newly enacted Japan's Advance Filing Rules, to report electronically through NACCS to Japan Customs.

NACCS has focused its efforts on developing partnership with service providers from different areas to cover various ports with Japan bound vessels. Conex is the first service provider headquartered in Europe.

With 15 service providers (13 overseas and 2 Japanese) in total including Conex, NACCS Center is building a cooperative framework to be fully ready for the electronic filings from overseas.
