1. Procedure Outline

IML procedure will be used to inquire listed vessel information *2 and B/L number etc. which has been registered via "Advance Cargo Information Registration (AMR)" or "Update Registered Advance Cargo Information (CMR)" (hereinafter, AMR or CMR) or "Advance Cargo Information (House B/L) Registration (AHR)" or "Update Registered Advance Cargo Information (House B/L) (CHR)" (hereinafter, AHR or CHR), in the unit of each carrier (each vessel operator in the case of joint vessel operation), or in the unit of Master B/L*1.

Status of Actual Departure Time Registration in the unit of each Port of Loading is also available via this procedure.

- 4. Input Conditions
 - (1) Inquirer verification
 - 1 Inquirer is already registered in the system.
 - ② In case inquirer is Shipping Agent and the port of cargo discharge is registered, the consigner-consignee relationship between Carrier and Shipping Agent should be registered in the system at the registered port of cargo discharge.
 - (2) Input field verification

In case "D" is entered as query type, Advance Filing by "AMR or CMR" or "AHR or CHR" should have been done for the queried vessel information*2.

- 5. Processing Details
 - (1) Input data verification

If the above-mentioned input conditions are met, the process result code "00000-0000" should be set before proceeding to the steps to follow.

If the above input conditions are not satisfied, which means an error, other code than "00000-0000-0000" should be set to deliver the relevant process result notification output. (For details of errors, see the "List of Process Result Codes".)

(2) Extraction of referable B/L

B/Ls which meet the following conditions will be extracted from Advance Cargo Information DB.

- (A) Query Type "A"
 - (a) Ocean (Master) B/L Number Extraction

Extract Ocean (Master) B/L Number whose Vessel information*2 registered in the system is same as queried Vessel information*2.

In case inquirer is Carrier, Shipping Agent (the port of cargo discharge is not registered), NVOCC or Service Provider, extracted B/L Number is limited to the one which also meets the following conditions.

(i) In case inquirer is Carrier

Extract Ocean (Master) B/L Number which meets one of the following conditions:

Extract Ocean (Master) B/L Number which meets one of the following conditions;

(i) When Discrepancy Information of Advance Filing is registered to Ocean (Master) B/L Number;

1. Registered Vessel information of the Ocean (Master) B/L Number in the system is same as

queried Vessel information*2.

- (C) Query Type "C"
 - (a) Ocean (Master) B/L Number Extraction

Extract Ocean (Master) B/L Number which meets one of the following conditions;

- (i) When Advance Notice of Risk Assessment Result is registered to Ocean (Master) B/L Number;
- 1. Registered Vessel information: 2 of the Ocean (Master) B/L Number in the system is same as queried Vessel information: 2.
- 2. Advance Notice of Risk Assessment Result is registered to the Ocean (Master) B/L Number.
- (ii) When Advance Notice of Risk Assessment Result is registered to relevant House B/L Number:
 - 1. Registered Vessel information:2 of the Master B/L Number in the system is same as queried Vessel information:2
 - 2. The Master B/L Number is related to the House B/L Number to which Advance Notice of Risk Assessment Result is registered.

From Ocean (Master) B/L Number which meets the above extraction conditions of Query Type "A", extract Ocean (Master) B/L Number which also meets one of the following conditions:

- 1) Advance Notice of Risk Assessment Result is registered to Ocean (Master) B/L Number
- 2 The Master B/L Number is related to the House Number to which Advance Notice of Risk Assessment Result is registered
- (b) House B/L Number extraction
 - 1. House B/L Number is related to the Master B/L Number extracted in 5. (2) (C) (a).
 - 2. Advance Notice of Risk Assessment Result is registered to the House B/L Number.

Extract House B/L Number which meets the above extraction conditions in Query Type "A" and to which Advance Notice of Risk Assessment Result is registered.

(D) Query Type "E"

Extract House B/L Number related to the queried Master B/L Number.

(E) Query Type "F"

Extract House B/L Number which meets both of the following conditions:

- 14. House B/L Number is related to the queried Master B/L Number
- 22. Discrepancy Information of Advance Filing is registered to the House B/L Number by ATD

(F) Query Type "G"

Extract House B/L Number which meets both of the following conditions:

- 14. House B/L Number is related to the queried Master B/L Number
- 22. Advance Notice of Risk Assessment Result is registered to the House B/L Number

(3) Extraction of referable Port of Loading

When Query Type is "D", Port of Loading which is same as the queried Vessel Information*2 will be extracted.

(4) Inquiry about registered MB/L-HB/L List Information Edit & Output

Edit and Output Inquiry about registered MB/L-HB/L List Information (Relevant B/L List) etc. from Advance Filing DB for extracted B/L or Advance Filing Management DB for queried Vessel Information*2. Please see "6. Output Messages" for details of output information items.

(5) Output of warnings

Output warning messages in Inquiry about registered MB/L-HB/L List Information when Query Type is "A", "B" or "C", and there is more information other than information already has been output.

7. Special Notes

(1) B/Ls to be extracted

When query type is "A", "B" or "C", House B/L Number extracted is not "House B/L Number whose Vessel information*2 registered in the system is same as queried Vessel information*2".

Firstly, Master B/L Number whose Vessel information*2 registered in the system is same as queried Vessel information*2 will be extracted, then if the Master B/L Number has relevant House B/L Number, such House B/L Number will be extracted.

Thus, if there is discrepancy in vessel information between Master B/L and House B/L, "Vessel information*2 registered with Master B/L by AMR or CMR" is required for query rather than "Vessel information*2 registered with House B/L by AHR or CHR".
